# NEW BUSINESS RESOLUTIONS

## RESOLUTION R-2023-124

Resolution of the Board of Commissioners of Lawrence County to post the sale of a 2000 Ford Truck and a 1998 Ford Club Wagon Van; and

**WHEREAS**, the vehicles are a 2000 Ford Truck and a 1998 Ford Club Wagon Van with mileage at 74,009 on the truck and 90,004 on the van, both in poor condition; and

WHEREAS, each vehicle is worth less than \$2,000.00; and

**NOW, THEREFORE BE IT BE RESOLVED** that the County post the sale of the 2000 Ford Truck and a 1998 Ford Club Wagon Van at the Lawrence County Courthouse for bids on the vehicles.

#### RESOLUTION R-2023-125

**WHEREAS**, the Commonwealth of Pennsylvania, under Act 101 Section 903 has provided funds for the reimbursement of 50% of the salary and eligible expenses of county recycling coordinator positions, and

**WHEREAS,** the County of Lawrence staffed this position funded through the Recycling/Solid Waste Budget, and

**WHEREAS**, the County of Lawrence, through the Department of Recycling/Solid Waste, is preparing the application for reimbursement for these expenses to be submitted to the Pennsylvania Department of Environmental Protection; and

**NOW, THEREFORE, BE IT RESOLVED,** by the Lawrence County Board of Commissioners that the Act 101 Section 903 Grant application for reimbursement of the salary and eligible expenses for 2022, for the county recycling coordinator, be submitted to the Pennsylvania Department of Environmental Protection.

#### RESOLUTION R-2023-126

WHEREAS, the Lawrence County Commissioners desire to contract certain services; and

WHEREAS, the County has the authority and duty to provide services; and

**WHEREAS**, the County Commissioners Association of Pennsylvania (CCAP) provides a Web Program for Pennsylvania government entities. This program has been in production for over 18 years. Their expertise is understanding government services and structure and aligning their program offerings to the same. They support a wide variety of counties in their website journey to include design, hosting and supportive services; and

WHEREAS, the County wishes to enter into an Agreement with CCAP Technology Web Services to create a new website for Lawrence County that will span each area identified in the attached Statement of Work Section III: Objectives; and

WHEREAS, the annual fees for these services will be as follows:

- 1. The first half payment at upon execution of the Statement of Work; and
- 2. The second and final payment upon completing the project; and

- 3. Final payment in full is due within 30 days of completing the project; and
- 4. The Total Engagement Estimate is \$22,350.00

**WHEREAS**, the term of this Web Program Enrollment Agreement is as follows:

- 1. Commence on the Enrollment Date of April 12, 2023 and continue within the calendar year of the Enrollment Date to December 31, 2023; and
- The Agreement term renews each subsequent calendar year beginning January 1 and ending December 31, unless terminated or not renewed pursuant to the terms of this Agreement; and
- 3. The County (Member) is required to provide CCAP with 90 days written notice, prior to termination of the then-current term, of its intent not to renew the Agreement Term

NOW THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that a Web Program Enrollment Agreement and a Statement of Work be approved and executed to provide website services for Lawrence County.

#### RESOLUTION R-2023-127

WHEREAS, the County entered into a Retainer Agreement for Securities Monitoring and Claims Filing between the Lawrence County Employees' Retirement Board ("Client") and Kessler Topaz Meltzer & Check, LLP ("KTMC"), formerly known as Barroway Topaz Kessler Meltzer & Check, LLP, dated September 14, 2010; and

**WHEREAS**, for the services it provides under this Agreement, KTMC shall be compensated on a contingency basis of four percent (4%) of gross recoveries from settlement or other claims filed by KTMC on Client's behalf in shareholder and antitrust litigation in the United States and globally; and

**WHEREAS**, this Addendum shall be effective on January 1, 2023; and remain in effect until December 31, 2024, at which time both parties will evaluate this fee addendum for renewal; and

NOW THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that the attached Addendum to Retainer Agreement for Securities Monitoring be approved, effective January 1, 2023 through December 31, 2024.
