### RESOLUTION R- 2023-366

**WHEREAS,** The Lawrence County Register and Recorder has established a goal of lowering the costs when requesting a retrieval of a record from Access.

**WHEREAS**, The Register and Recorders Office is currently using Access Information Management of Wisconsin LLC for storage and retrieval of records. The cost for retrieval of stored records is normally \$65.88 per record. This becomes quite costly when requesting more than one record.

WHEREAS, Access Information Management of Wisconsin LLC offers Access Unify which is a Digital Delivery service with a flat rate billed at \$79.00 per month. This fee includes up to three (3) retrievals per month. If one month there are not three (3) retrievals, they will carry over to the next month. On average, the Register and Recorders Office requests 3 retrievals per month. We will save an average of \$128.00 per month implementing Access Unify. This is a savings of \$1,536.00 per year.

**WHEREAS**, The term of this Contract shall be for one (1) year.
