WHEREAS, Section 603 of the federal American Rescue Plan Act ("ARPA"), which became law on March 11, 2021, establishes a Coronavirus Local Fiscal Recovery Fund ("FRF" or "Local Fiscal Recovery Fund"); and

WHEREAS, the American Rescue Plan Act requires that Local Fiscal Recovery Fund money be used for expenditures on or after March 3, 2021 (1) to respond to the COVID-19 public health emergency or its negative economic impacts; (2) for the provision of government services to the extent of the reduction in revenue of the applicable local government due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year of the local government; (3) for premium pay for essential workers; and (4) to make necessary investments in water, sewer, or broadband infrastructure; and

money to eligible entities for permissible expenditures; and

WHEREAS, the County has allocated \$200,000.00 to BC3 for enhancements and capital improvements to its Lawrence County Building; and

NOW, THEREFORE IT BE RESOLVED, by the Lawrence County Commissioners, that the Board of Commissioners approves an allocation of \$200,000.00 to BC3.
