NEW BUSINESS RESOLUTIONS

RESOLUTION R-2024-89

WHEREAS, the Mental Health and Intellectual Disability Act of 1966 allows for the purchase of appropriate services; and

WHEREAS Lawrence County, through its Mental Health and Developmental Services contracts for certain services; and,

WHEREAS the Mental Health and Developmental Services is responsible for the diagnosis, care, treatment, and rehabilitation of County residents who are mentally disabled; and

WHEREAS, from time to time it is necessary to make amendments to the original Agreement;

WHEREAS, the Lawrence County Mental Health and Developmental Services currently has a Base contract with <u>Vocational & Psychological Services</u> for the period from July 1, 2023, through June 30, 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS THAT:

- 1. It is specifically understood and agreed that the stated maximum of \$135,000.00. for various services shall be adjusted to \$215,000.00. Revised budget page(s) is/are attached to support these changes. There is no language change to this contract.
- 2. All provisions of the agreement dated **July 1, 2023**, between the parties shall remain as heretofore established.

RESOLUTION R-2024-90

WHEREAS, Lawrence County, through its Children and Youth Department, desires to contract certain social services; and

WHEREAS, the County has the authority and duty to provide social services to children and youth subject to the regulations established by the Commonwealth of Pennsylvania (DHS) and the Juvenile Code:

NOW, THEREFORE, be it resolved by the Lawrence County Board of Commissioners, that:

- 1. The Purchase of Service Agreement under the provider Crossroads Group Homes and Services, Inc. shall be in effect for the period of July 01, 2024, through June 30, 2025.
- 2. Costs are incurred only if the provider or service is being used by Lawrence County per the Agreement.
- 3. Authorization is hereby given to execute an Agreement with the following service provider:

RESOLUTION R-2024-91

WHEREAS, the Lawrence County Department of Public Safety has entered into a planned maintenance agreement with Penn Power Systems, 21260 route 19, Cranberry Twp., PA 16066, (hereinafter "Penn Power Systems") to provide a three (3) year Maintenance Agreement, attached hereto as Exhibit "A"

WHEREAS, Penn Power Systems agrees to provide a three (3) year Maintenance Agreement in the amount of Forty-two Thousand Nine Hundred thirty-six and thirty-nine (\$42,936.39). This agreement will not be construed to create a partnership, joint venture or employment relationship between PENN POWER SYSTEMS and LAWRENCE COUNTY. PENN POWER SYSTEMS will not represent itself to be an employee or agent of LAWRENCE and cannot enter into any agreement on LAWRENCE's behalf or in LAWRENCE's name without express written authorization from a duly authorized representative of LAWRENCE to do so.

NOW, THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS that authorization is given to execute on behalf of the Lawrence County Department of Public Safety, all documents related to the Penn Power Systems planned maintenance agreement to provide a three (3) year agreement. Penn Power Systems will perform the services not to exceed the total amount of Forty-two Thousand Nine Hundred thirty-six dollars and thirty-nine cents (\$42,936.39).
