WHEREAS, the term of this agreement is for a one (1) year period beginning January 1, 2024, through December 31, 2024. The total consideration payable to QEMS for the lease of the software program and all related professional services set forth in Exhibit "A" shall not exceed \$25,000.00 for the first year.

WHEREAS, on August 15, 2023 Resolution R-2023-277 was approved for Armstrong County to pay \$800.00 per juvenile offender, per day to Lawrence County to house Interest of Justice-Direct File juveniles charged as adults; and

WHEREAS, the Lawrence County Prison Board voted on September 20, 2023 to reduce the fee from \$800.00 per juvenile offender, per day to \$600.00 per Interest of Justice-Direct File juveniles charged as adults, per day; and
