NEW BUSINESS RESOLUTIONSRESOLUTION R-2024-369

WHEREAS, the Pennsylvania Commission on Crime and Delinquency (PCCD) has applied for and received grant funds to implement a SAVIN program in Pennsylvania; and

WHEREAS, PDAI (Pennsylvania District Attorneys Institute) has been selected a subgrantee by PCCD to provide contract administration and maintenance fee collections; and

WHEREAS, Lawrence County has committed to implementing and using the PA SAVIN system to meet and enhance its responsibilities for victim notification as well as provide additional notification services to county residents; and

NOW THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS; that

1. An agreement is made and entered into by and between PCCD, (Pennsylvania Commission on Crime and Delinquency, PDAI, (Pennsylvania District Attorneys Institute), and Lawrence County to implement a SAVIN program.

RESOLUTION R-2024-370

WHEREAS, the County of Lawrence is using a Grant from the Pennsylvania Department of Community and Economic Development's Keystone Communities Program;

WHEREAS, eligible applicants can apply and receive up to \$5,000 dollars towards Façade improvement;

RESOLUTION R-2024-371

WHEREAS, the 9-1-1 Statewide Interconnectivity Funding Grant Agreement ("Agreement") is entered into by and between the Commonwealth of Pennsylvania ("Commonwealth"), acting through the Pennsylvania Emergency Management Agency ("PEMA"), and Lawrence County ("Subgrantee") and attached hereto as Exhibit "A"

WHEREAS, the Act of June 29, 2015, P.L. 36, No. 12, as amended, 35 Pa. C.S. §§ 5301- 5399, established the 9-1-1 Fund. Money in the 9-1-1 Fund and the interest the money accrues is appropriated to PEMA to be disbursed by PEMA. Up to 15% of the amount in the fund shall be used by PEMA to establish, enhance, operate or maintain statewide interconnectivity of Public Safety Answering Points (PSAPs), hereinafter referred to as statewide interconnectivity funding;

WHEREAS, statewide interconnectivity funding made available to PSAPs will be distributed through a grant process in accordance with the guidelines and application procedures published by PEMA;

WHEREAS, PSAPs may apply for statewide interconnectivity funding to complete specific projects that align with the objectives and priorities set by PEMA, in consultation with the 9-1-1 Advisory Board, for the use of statewide interconnectivity funding;

WHEREAS, PEMA has identified the Subgrantee as an eligible recipient of statewide interconnectivity funding to establish, enhance, operate or maintain statewide interconnectivity of PSAPs; and the purpose of this Agreement is to set forth the responsibilities between PEMA and the Subgrantee for the distribution and use of statewide interconnectivity funding for the Lawrence County, Butler/Lawrence Recorder Maintenance, 2024-0138; ICORRS Master Site Maintenance 2024-0130; NG911 GIS Post Migration 2024-0042; and WestCORE ESInet Maintenance 2024-0112.

NOW, THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that authorization is given to execute on behalf of the Lawrence County Department of Public Safety, all documents related to the 2024

9-1-1 Statewide Interconnectivity Funding Grant Agreement as follows:

AWARD AMOUNT

- 1. PEMA shall award \$94,732.14 from the 9-1-1 Fund to the Subgrantee for the following projects:
 - a. \$11,885.00 for Butler/Lawrence Shared Recorder, project number 3120240138;
 - b. \$49,257.54 for ICORRS Master Site Maintenance, project number 3120240130;
 - c. \$25,000.00 for Lawrence NG911 GIS Post Migration, project number 3120240042; and
 - d. \$8,589.60 for the WestCORE ESInet Maintenance, project number 3120240112;
- 2. The period of performance of this Agreement is January 1, 2025, through December 31, 2025.

INTRODUCTION OF THE 2025 LAWRENCE COUNTY BUDGET

WHEREAS, the fiscal year of the County begins on the first day of January; and

WHEREAS, the Board of Commissioners of Lawrence County are required by County Code to adopt a budget by the end of the calendar year; and

WHEREAS, the County Code requires the proposed budget be available for public inspection at least twenty (20) days prior to its adoption; and

WHEREAS, the Board of Commissioners has collaborated with each County department to formulate a preliminary spending plan for the County; and

NOW, THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, THAT: in accordance with §1782 of the County Code, a proposed budget is hereby introduced for public review until December 31, 2024, the day set for final adoption.

The Commissioners and Mr. Venasco thanked all those individuals, Controller Prestopine, Mr. Albert Antonelli and all the Department Heads and Elected Officials, involved in helping Mr. Venasco with creating the budget. This is a balanced budget and property taxes are not increasing for 2025. Mr. Venasco stated the department heads and elected officials were all great to work with. The (2) biggest increases in the budget were union negotiations and a decrease in our healthcare of 1%. Our workers compensation insurance also decreased by 27%.

RESOLUTION R-2024-374

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF LAWRENCE COUNTY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2025 AND APPROPRIATING SPECIFIC SUMS, ESTIMATED TO BE REQUIRED, FOR THE SPECIFIC PURPOSES OF COUNTY GOVERNMENT, HEREINAFTER SET FORTH.

BE IT RESOLVED AND ENACTED, AND IT IS HEREBY RESOLVED AN ENACTED BY THE BOARD OF COMMISISONERS OF THE COUNTY OF LAWRENCE, COMMONWELATH OF PENNSYLVANIA, that:

SECTION 1: a tax be, and is hereby levied, on all real property within the County subject to taxation for County purposes for the Fiscal Year 2025. The tax rate for County purposes shall be as follows:

- **a.** For <u>General Purposes</u>, the sum of seven and five hundred, twenty eight-thousandths (7.528) mills and on each dollar of assessed valuation (or the sum of seventy-five and twenty eight-hundredths cents [75.28¢] per each one hundred dollars [\$100.00] of assessed value.)
- **b.** For <u>Debt Purposes</u>, the sum of six hundred and forty-six thousandths **(.646)** mills on each dollar of assessed valuation (or the sum of six and forty-six hundredths cents (6.46¢) per each one hundred dollars [\$100.00] of assessed value.)
- c. For <u>Special Purposes</u> (libraries), the sum of one hundred and thirty-five thousandths (.135) mills on each dollar of assessed valuation [or the sum of one and thirty-five hundredths cents [1.35¢] per each one hundred dollars [\$100.00] of assessed value.)

The **total millage** for all County purposes shall be eight and three hundred and nine thousandths **(8.309) mills** (or the sum of eighty three and nine hundredths cents [83.09¢] per each one hundred dollars [\$100.00] of assessed value.)

SECTION 2: for the expenses of the County for the **Fiscal Year 2025**, the amounts are hereby appropriated from the revenues available for the specific purposes set forth above, which amounts are more fully itemized in the **County Budget** on file in the office of the Commissioners.

SECTION 3: any resolution, or parts thereof, conflicting with this Resolution shall be repealed, insofar as the same affects this Resolution.
