RESOLUTION

R-2023-434

WHEREAS, the Lawrence County Department of Public Safety has entered a proposal to provide Subscription Based Web Application Services or Software as a Service (Saas) with OnSolve, LLC with its principal office at 780 West Granada Boulevard, Ormond Beach, FL 32714.

WHEREAS, OnSolve, LLC agrees to provide a one (1) year license commencing on January 1, 2024, which includes 24/7/365 uninterrupted CodeRed system access as well as other services explained in the Cost Proposal at an annual cost of Eight Thousand Eight Hundred Ninety-four Dollars and ten cents (\$8,894.10) annually.

WHEREAS, the Lawrence County Commissioners recognize there is a need for broadband expansion to bring service to currently unserved and underserved areas of the County; and

WHEREAS, the Commissioners directed the Department of Planning and

Community Development to pursue an assessment of gaps, needs, and interests; and

WHEREAS, the County engaged the professional services of Michael Baker International to gather data about the County through research, geographic information service mapping, surveys, public outreach, stakeholder engagement, and a task force; and

WHEREAS, the County documented areas needing service, identified broadband expansion opportunities, outlined potential projects, and provided goals and recommendations for advancing the County's broadband interests.

NOW, THEREFORE BE IT RESOLVED by the Lawrence County Board of Commissioners that the Lawrence County Commissioners:

- 1. support broadband expansion and digital equity throughout the County, demonstrated by an initiative that captured qualitative and quantitative data;
- 2. documented the voids in existing broadband service to close the digital divide and bring internet access to everyone throughout the county;
- 3. developed a report outlining the state of broadband, identified project opportunity areas, and established actionable goals and next steps; and
- 4. hereby adopt the Broadband Expansion Study as prepared by Michael Baker International.

Courtney Accurti and Joe Bzorek from Michael Baker International gave a presentation on the findings of the Broadband Study. They thanked everyone for all involvement and had all positive reviews of the study. Jeff Bishop, Plain Grove Township Supervisor and Amy McKinney, Director of Planning were part of the team with Michael Baker that worked on the study.

The Commissioners thanked everyone involved and hope that all of Lawrence County residents receive the internet access they deserve and need.

Mr. Bzorek thanked the Commissioners for the County's vision and open communication.

Mr. Bishop stated COVID was really the eye opener for showing the necessity of internet for kids needing internet access to do school work from home.

RESOLUTION R-2023-436

WHEREAS, the County of Lawrence has received notification from the Commonwealth of Pennsylvania, Department of Community and Economic Development of the availability of funding in the projected amount of \$622,739.00 (\$259,339.00) for the County of Lawrence, \$129,442.00 On Behalf of the Township of Shenango, \$105,641.00 On Behalf of the Township of Union and \$128,317.00 On Behalf of Ellwood City Borough) for the provision of services eligible under the Community Development Block Grant (CDBG); and

WHEREAS, the County of Lawrence wishes to engage in the provision of services eligible under the Community Development Block Grant Program; and

WHEREAS, the Township of Shenango, the Township of Union and Ellwood City Borough have directed and agreed on the purpose of the CDBG funds set aside for their community; and

WHEREAS, the First Public Hearing was advertised and conducted on June 12, 2023 (at the County of Lawrence, at and On Behalf of Ellwood City Borough, at and On Behalf of Shenango Township and at and On Behalf of Union Township). The second Public hearing was advertised and conducted on September 26, 2023 (County of Lawrence and On Behalf of Shenango Township, Union Township and Ellwood City Borough) as required by the CDBG regulations, to obtain citizens views and comments concerning the proposed use of these funds.

NOW, THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that;

- 1. The County shall prepare and submit a grant in the projected amount of \$622,739.00, to the Department of Community and Economic Development.
- 2. The County has chosen to allocate their allocation to the following eligible projects:
 - a. Housing Rehabilitation \$105,781.00 in non-entitlement communities
 - b. Public Services \$107,558.00
 - c. Program Administration \$46,000.00
- 3. The County of Lawrence on Behalf of Shenango Township has chosen to engage in Parks and Recreation and Program Administration.
- 4. The County of Lawrence on Behalf of Union Township has chosen to engage in Housing Rehabilitation and Program Administration.
- 5. The County of Lawrence on Behalf of Ellwood City Borough has chosen to engage in Curb Ramps, Housing Rehabilitation and Program Administration.
- 6. The said program activities will be administered in accordance with all State and Federal Regulations.

7. The Chairman Commissioner shall have the authority to execute all documents required by the

Commonwealth of Pennsylvania pertaining to the application and administration of the 2023 CDBG Program.
