Mr. Vogler stated he received an update from our Controller and County Administrator and at the end of the 1st quarter, expenditures are at 24.9% and revenue is at 25.6%. Great news.

He was very impressed with the students and the programs that they graduated from. Second, all three (3) Commissioners attended the CCAP District 2 meeting, that is chaired by Commissioner Vogler. Mr. Burick stated he got to meet with 11 Southwest Pennsylvania counties. Lastly, yesterday the three (3) Commissioners attended Lawrence County Law Day. He congratulated the winners of the essay contest, both from Wilmington Township School District, Kinsley Shimrack and Annalee Gardner.

NEW BUSINESS RESOLUTIONS

RESOLUTION R-2023-134

WHEREAS, the Lawrence County Register has established a goal of converting existing records to a more permanent medium; and

WHEREAS, GOVOS has provided a Statement of Work to convert all images to PDF/A provided by the County. Deeds – 3,868,396 images Wills – 1,117,133 images. The

fee for this service is a one- time cost of \$17,000.00 to convert the images. This fee came out of the Records Improvement Fund and not from the General Fund; and

WHEREAS, GOVOS will no longer provide microfilm back up for images. Instead of microfilm, GOVOS will provide go-forward services to Export/Uploaded PDF/A from CountyFusion to 2 secure hosted locations by GOVOS and Amazon Web Services. This service will occur weekly. The invoiced amount for this service will be billed annually in the amount of \$3,862.00. This amount is budgeted and paid for from the Records Backup line item from the Register and Recorder's Budget; and

NOW, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS; that:

- GOVOS, a Kofile Company 6300 Cedar Springs Road Dallas TX 75235 and the Lawrence County Register and Recorder's Office will enter into this Agreement for conversion of images to PDF/A and for services to Export/Uploaded PDF/A from CountyFusion to 2 secure locations.
- 2. Terms shall be as identified in the attached agreement.

RESOLUTION R-2023-135

WHEREAS, the Pennsylvania Department of Human Services has made funds available to the County of Lawrence for the sole purpose of retaining and attracting vehicle operators for the Medical Assistance Transportation Program; and

WHEREAS, these funds were paid to County of Lawrence during April 2023, in the amount of \$164,440.44; and

WHEREAS, Lawrence County Social Services is the Medical Assistance Transportation Provider Administrator on behalf of the County of Lawrence; and

WHEREAS, Lawrence County Social Services wishes to disperse these funds in accordance with directives provided by the PA Department of Human Services to the three (3) transportation providers currently providing MATP trips.

NOW, THEREFORE, BE IT RESOLVED by the Lawrence County Board of Commissioners, that;

1. The County of Lawrence does authorize payment to Lawrence County Social Services, Inc. in the amount of \$ 164,440.44.

2. Lawrence County Social Services, Inc. will disperse these funds to the three (3) transportation providers based on the proportion of trips each provider delivered during Fiscal Year 2021-22 in the following amounts:

a. Allied Coordinated Transportation Services
b. New Castle Area Transit Authority
c. Noga Wheelchair Transport Service

RESOLUTION R-2023-136

A RESOLUTION OF THE LAWRENCE COUNTY BOARD OF COMMISSIONERS AUTHORIZING AN ALLOCATION FROM THE ACT 137 FUNDS TO MISSION BARN

WHEREAS, Lawrence County Ordinance No. 203 of 1996 authorized the Recorder of Deeds to increase the fees charged for recording deeds and mortgages and to set aside a portion of those fees in a separate account to be used to fund affordable housing efforts; and

WHEREAS, the Mission Barn is an independent non-profit corporation that works closely with The United Methodist Church in providing modular access ramps to individuals who need assistance in accessing their homes; and

NOW, THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that the Mission Barn of 181 Columbus Drive, New Castle, PA, 16101, is hereby awarded \$15,000.00 from the Affordable Housing Fund to be used for the construction of access ramps to those in need throughout Lawrence County.
