Mr. Burick also commended 911/Public Safety. He also stated about the passing of Judy Germani.

Mr. Vogler commended 911/Public Safety. He also asked Ms. Spielvogel to explain what the meeting in Pittsburgh next week is that she'll be attending.

Ms. Spielvogel stated the meeting is to discuss accommodating juveniles at our jail. The Warden is also attending.

RESOLUTION R-2023-231

WHEREAS, Governor Josh Shapiro announced that Norfolk Southern Corporation, at his request, sent \$1 million directly to communities in Western Pennsylvania to assist with community relief following the company's February train derailment; and

WHEREAS, Beaver County has received \$660.000.00 and has to directed those dollars to Darlington Township and Lawrence County has received \$340,000.00 to use for community relief; and

WHEREAS, local leaders in Darlington Township (Beaver County) and Lawrence County will determine how this funding will be directed to benefit their respective communities; and

WHEREAS, the Commissioners would like to divide the funding three (3) ways, amongst Little Beaver Township, Enon Valley Borough and the Lawrence County Conservation District: and

WHEREAS, funding would be as follows:

- 1. Little Beaver Township-\$120,000.00; and
- 2. Enon Valley Borough-\$115,000.00; and
- 3. Lawrence County Conservation District-\$105,000.00

NOW, THEREFORE BE IT RESOLVED by the Lawrence County Board of Commissioners, that the above allocations from Norfolk Southern Corporation's relief funding be made to the above entities.

Mr. Burick thanked Mr. Vogler for his lead role on this issue. Mr. Burick believes the money will be spent appropriately.

Ms. Spielvogel also thanked Mr. Vogler.

Mr. Vogler stated that it was a team effort from all three (3) Commissioners, Norfolk Southern and Governor Shapiro. He also stated Norfolk Southern will be providing funds to the Lawrence County Fire Departments that assisted with the train derailment.
