WHEREAS, there are currently six (6) Security Screener positions

WHEREAS, the Sheriff is seeking one (1) On-Call Security Screener to cover absences of current staff

WHEREAS, this position can only be utilized when an existing Security Screener is temporarily unable to perform his/her duties

WHEREAS, at no time will there be more than six (6) Security Screeners active at one time

NOW, THEREFORE BE IT RESOLVED BY THE LAWRENCE COUNTY SALARY BOARD, that:

1. The position of On-Call Security Screener be created at a rate of \$13.00/hr, retroactive to March 1, 2023. Moved by Mr. Quahliero, seconded by Mr. Prestopine to approve said Resolution. Motion carried 4-0.
