**WHEREAS,** Section 603 of the federal American Rescue Plan Act ("ARPA"), which became law on March 11, 2021, establishes a Coronavirus Local Fiscal Recovery Fund ("FRF" or "Local Fiscal Recovery Fund"); and

**WHEREAS**, the American Rescue Plan Act requires that Local Fiscal Recovery Fund money be used for expenditures on or after March 3, 2021 (1) to respond to the COVID-19 public health emergency or its negative economic impacts; (2) for the provision of government services to the extent of the reduction in revenue of the applicable local government due to the COVID–19 public health emergency relative to revenues collected

in the most recent full fiscal year of the local government; (3) for premium pay for essential workers; and (4) to make necessary investments in water, sewer, or broadband infrastructure; and

**WHEREAS**, the County is distributing Local Fiscal Recovery Fund money to eligible entities for permissible expenditures; and

**WHEREAS**, the County has allocated eight hundred thousand dollars (\$800,000.00) to the City of New Castle for their commercial revitalization efforts.

**NOW, THEREFORE IT BE RESOLVED**, by the Lawrence County Commissioners, that the Board of Commissioners approves an allocation of eight hundred thousand dollars (\$800,000.00) to the City of New Castle.

Mayor Cameron stated the City will be putting in \$500,000.00 as well towards the demolition of the First Merit Building, the green space that will be created and the façade program to twelve downtown businesses that have committed funds.
