AND NOW, this _____ day of _____, 20____, it is hereby ORDERED and DECREED that the Plaintiff, _____ and the Defendant, _____, are divorced from the bonds of matrimony.

The parties shall reaffirm or change the beneficiary status of any life insurance policies, annuity contracts, pensions, profit sharing plans, or other contractual arrangements providing for payment to a spouse if it is the intention of one of the parties to keep or change to other party as beneficiary. Failure to do so may result in revocation of the beneficiary designation pursuant to 20 Pa C.S. § 6111.2 (Effect of Divorce or Pending Divorce on Designation of Beneficiaries).

The Court retains jurisdiction of any claims raised by the parties to this action for which a final order has not yet been entered.

Any existing spousal support order shall hereafter be deemed an order for alimony pendente lite if any economic claims remain pending.
