RESOLUTION R-2024-

WHEREAS, Lawrence County solicited bids for the FY2022 Curb Ramp Improvement Project – Bid #2 in Ellwood City under the FY 2022 CDBG program; and

WHEREAS, the Lawrence County Department of Planning and Community Development reviewed the bids and reported that Fryer Excavating, LLC, 338 Concord Church Road, Beaver Falls, PA 15010 was the lowest responsible bidder with a bid of \$88,426.11; and

- 1. Fryer Excavating LLC is awarded the bid for the completion of the FY2022 Curb Ramp Improvement Project under the FY2022 CDBG program.
