 - 1. Countywide Blight Removal Program Update -
 - **First Merit** We have come to an agreement with DORE & Associates regarding the change order for the additional asbestos abatement at the First Merit building located at 25 N. Mill Street. The original change order was submitted November 3rd, 2023, in the amount of \$146,770.00. R.A.R. Engineering was instrumental in negotiating with DORE & Associates, Inc. to get the change order revised to \$82,000.00. We went into this project knowing that additional asbestos abatement may be required and feel that the documentation provided justifies the change order.
 - Round 1 2023 –

Parcel 33-045600 - 403 4th Street, West Pittsburgh – The sewage lien has been released by the Township and Fryer Excavating is requesting a demolition permit so clearing of the property can begin.

DON Enterprises RACP Application Update- Linda Nitch of DON Enterprises Inc.
updated the board on the application status stating that she spoke with one of the
analysts and they are hoping that they will have a decision within six weeks.

2. Façade Update -

 We received all follow up documentation from Leaps & Bounds Gymnastics and have their reimbursement listed on the Action Agenda – Approval of Bills. We are going to accept applications for the next round of funding and those will be on a first come first served basis.

3. Side Lots -

Two applications have been received and are listed under the action agenda.

4. Vacant Lots -

■ DON Enterprises Inc – Robert DiBuono addressed the board to request purchase of ten Repository lots. Currently DON Enterprises Inc has completed twelve Federal Home Loan (FHL) builds and the thirteenth will be completed soon. This will complete their first three FHL grants. Currently, they have four buildable lots and with these ten additional lots they will be able to consolidate them into another four building sites. A hold has been placed on these lots and DON Enterprises has submitted the required application with payment. Also, Mr. DiBuono informed the board that DON Enterprises Inc has funding set aside for the Side Yard program which would give financial assistance to property owners who would like to purchase side lots but are not financially able to.
