# **ELECTION DIRECTOR'S REPORT**

Tim Germani stated that the official candidate list has been posted and that the 3 court cases have been resolved. They are now able to begin with a rough draft of the ballots. He predicts that at the end of September the Ballots to be sent out if everything goes according to plan. He also stated that the electronic ballots go out today via e-mail for those who are deployed overseas. Mr. Germani gave the following statistics of total voters for the mail in and absentee ballots. There are 6,830 total, Republicans 2,288, and Democratic 4,042. Mr. Germani announced that the last day to apply for mail in ballots is October 29,2024, and the last day to register to vote is October 21st.
