Mr. Vogler stated the County lost two (2) gentlemen that served in local municipal government. Mr. Michael Ferraro was formerly on Bessemer Borough Council and served as a former Mayor. Further, Mr. Don Little, former Volant Borough Council member, both passed away.

Mr. Burick stated Over the last two weeks, I spent a lot of time working on Election Board issues to prepare for and conduct the 2023 General Election. I commend the county elections staff and people who worked on our behalf at the polls on a great job. The Election Board will meet in about two weeks to review the results and any other issues or concerns that arose.

I attended the following meetings:

- The Lawrence County Planning Commission meeting held at Shenango Township Municipal building.
- I met with the staff of the Lawrence County Housing Authority and State Representative Marla Brown to go over current issues and concerns related to public housing.
- I participated in the LEPC (Local Emergency Planning Committee) at the county Department of Public Safety.
- I attended a webinar hosted by the Council on Foreign Relations on the current situation in Israel.
- I attended an Opioid Education Program held at Neshannock High School sponsored by the Lawrence County Medical Society. Many great speakers gave talks on different aspects of the Opioid epidemic including a Deputy County Coroner who stated that almost all drugs involved in the cases he has handled have been laced with Fentanyl. Last year our county had 85 overdoes deaths and so far, this year we have had 51. That is 51 too many but at least that number is decreasing, and I hope that the efforts of all those working on this issue keep those numbers moving in a downward trend.

Ms. Spielvogel stated she attended a lot of the same meetings Mr. Burick reviewed. She wished the new Commissioners, Dan Kennedy and Chris Sainato well in the coming year. She further discussed the 911 system and how a surcharge should be placed on cell phones versus the tax payers of the County having to pay out of pocket costs to fund the 911 system. It is an essential part of life that must be kept up to date and running efficiently.
