## **Property Owner:**

The Redevelopment Authority of Lawrence County welcomes donations of properties under the following conditions:

- Real estate taxes *must be paid in full* at the time of donation, unless the property is eligible for a Deed in Lieu of Foreclosure.
- The property *shall not* have any judgment liens or other encumbrances, which may include but are not limited to mortgages, unpaid water bills, mechanic's liens and state or federal income tax liens.
- The property *shall not* have open code violations, unless the Redevelopment Authority determines that demolition of a structure is necessary, and funding is available.

The Redevelopment Authority requests a recent title search of the aforementioned parcels to prove ownership and that the property is free of liens and encumbrances. You may contact a title agency to order title work or reimburse the Redevelopment Authority for the cost of title work. At present, we are paying from \$100 to \$125 for title reports without insurance. If you wish to reimburse the Redevelopment Authority, please contact us first so we can confirm the amount. Also, payment will be required in certified funds, not personal checks.
