NEW BUSINESS RESOLUTIONS

RESOLUTION R-2024-329

WHEREAS, the Lawrence County Correctional Facility seeks to provide educational services to inmates to assist with their rehabilitation and successful reentry into society; and

WHEREAS, Together Forward GED LLC, owned by **Marissa Heaney**, is qualified to provide **GED Preparation and Instruction Services** for inmates, including classroom instruction, preparation work, and professional development; and

WHEREAS, the Consultant Contract between Lawrence County and Together Forward GED LLC outlines the services to be provided, including 260 hours of classroom instruction, 130 hours of preparation work, and 52 hours for professional development annually, for a total compensation not to exceed \$22,672.26 over a two-year period, which will be reimbursed through PCCD Grant Number 41091; and

WHEREAS, the dual role of Marissa Heaney as both the owner of Together Forward GED LLC and an employee of the Lawrence County Children and Youth Services has been fully disclosed, and no conflict of interest exists under county or state policies; and

NOW, THEREFORE, BE IT RESOLVED, by the Lawrence County Board of Commissioners:

- The Consultant Contract between Lawrence County and Together Forward GED LLC, owned by Marissa Heaney, for the provision of GED Preparation and Instruction Services to inmates at the Lawrence County Correctional Facility is hereby approved.
- 2. The **Board of Commissioners** authorizes **Lawrence County Corrections** to execute the Consultant Contract on behalf of Lawrence County, and further authorizes the County Administrator/Chief Clerk to attest the execution of this agreement.
