**JOB TITLE:** Food Service Worker/Part Time Cook

**DEPARTMENT:** Jail

**STATUS:** Non-Exempt/Union

**GENERAL SUMMARY:** The incumbent of this classification coordinates preparation of all daily meals of inmates in a correctional setting and performs other duties as required.

**SUPERVISION RECEIVED AND EXERCISED:** Reports to and receives direction from the Food Service Supervisor.

#### ESSENTIAL JOB FUNCTIONS:

- Training and monitoring inmates in food service preparation, cleaning and storage in designated food service areas.
- Security and control of inmates assigned to the kitchen area.
- Security, control and accountability of all equipment, food and supplies.
- Daily food service reports.
- Inmate performance evaluations.
- Periodic checks for production and service policy/procedure compliance.
- Periodic safety checks of equipment in food service area.
- Assist with cooking, serving of food and general cleaning when necessary.
- Receives and checks shipments of food supplies in the absence of supervisor.
- Enforces and follows sanitation standards and cleaning standards.
- Maintains accurate production and other records, as required by governing agencies.

#### KNOWLEDGE, SKILLS AND ABILITIES:

- Knowledge of health codes and jail standards.
- Knowledge of food nutritional values and dietary requirements.
- Knowledge of the principles and practices of preparing hot and cold meal for a large group.
- Ability to prepare quality food.
- Ability to work with others and follow directions.
- Ability to react quickly and calmly in an emergency.
- Excellent communication and people skills.
- Productivity, adaptability, punctuality and a strong sense of self-control.

**MINIMUM JOB REQUIREMENTS:**

- Graduation from high school or possession of a GED certificate.

**WORKING CONDITIONS:**

- Must be able to physically respond to an emergency situation.
- Must be able to assist in an evacuation.

**OTHER REQUIREMENTS:**

- Possession of a valid driver's license is required.
- Lifting is required.
- Must be 21 years old or older.
