Electronics - All others (Towers, printers, microwaves, radios, VCRs, etc.)	35 cents/pound
Household Hazardous Wastes - All types	\$1.40/pound
Batteries & Fluorescent Lights - All varieties	\$1.20/pound
Propane Cylinders	\$10 each

APPLIANCES & TIRES (Tri-County CleanWays will collect payment in the form of cash or check for these items)

Appliances - Freon-containing (<i>refrigerators, air-conditioners, dehumidifiers, etc.</i>)	\$25 per item
